## Randolph Opening DPW Yard Drop-Off Center for 2025 Season

The Town of Randolph is pleased to announce the opening of the DPW Yard Drop-Off Center for the 2025 season. The center will be open to all Randolph residents for the disposal of yard waste, electronics, tires, and other hard-to-recycle items.

**Location:** 6 Carlino Way, behind Zapustas Ice Arena  
**Hours:** Every other Saturday, 8:00 a.m. – 2:00 p.m. on the following dates:

April 12, April 26, May 10, May 24, June 7, June 21,  
July 5, July 19, August 2, August 16, August 30,  
September 13, September 27, October 11, October 25,  
November 8, November 15, 2025.

### Important Guidelines:

- Open to **Randolph residents only**.
- **No commercial or hazardous waste** accepted.
- **Yard Waste:** A **Season Pass** is required to drop off yard waste.
- **Fee-Based Disposal:** Other items are collected on a fee schedule.

### Accepted Items & Fees: (cash, check or money order only)

- Yard Waste Season Pass ..... \$50
- Senior/Veteran Yard Waste Season Pass ..... \$25
- Small CRTs (TVs, Monitors) under 60 lbs..... \$20
- Large CRTs (TVs, Monitors) over 60 lbs: ..... \$50
- Electronics, Small Appliances, Printers, ACs, Microwaves..... \$5
- Propane Tanks (grill size): ..... \$6
- Car Tires (no rims): ..... \$8
- Truck Tires (no rims): ..... \$12

**Payment:** **Cash, check or money order** payable to **Town of Randolph** is required for CRTs, electronics, propane tanks, and tires.

A **Yard Waste Permit** is not needed for other items, as fees apply per item. **Town staff** have final authority on whether items comply with state regulations.
